FINRA Rule 1240 requires registered persons to complete the Regulatory Element annually by Dec. 31 for each registration that they hold. Regulatory Element provides training on significant rule changes and other regulatory developments relevant to each registration category. Registered individuals access Regulatory Element CE via FinPro.
